RELEASE AND INDEMNITY AGREEMENT

WARNING

UNDER MICHIGAN EQUINE ACTIVITY LIABILITY ACT, AN EQUINE PROFESSIONAL IS NOT LIABLE FOR INJURY TO OR THE DEATH OF A PARTICIPANT IN AN EQUINE ACTIVITY RESULTING FROM AN INHERENT RISK OF THE EQUINE ACTIVITY.

IN CONSIDERATION of being permitted to participate today and on any future days in equine activities of Dressage4Kids or at Hampton Green Farm, the host of the 2017 Lendon Youth Dressage Festival Midwest, included but not limited to boarding, training, exercising, riding or caring for the horses and ponies stabled at Hampton Green Farm, and the following mutual premises contained herein, the parties agree to the following:

1. Releasor has read the above warning as required by Michigan law and agrees in full to its provisions. Releasor further understands that it is Releasor's responsibility to carry full and complete insurance coverage on any and all horses owned by the Releasor on Hampton Green Farm premises for the Youth Festival, including all tack and equipment, trailers and barn materials.
2. Releasor acknowledges the inherent risks associated with any equine activity and assumes full responsibility for any and all risks including, without limitation, the risks of death, bodily injury, property damage, falls, kicks, bites, collisions with vehicles, horses or stationary objects, fire or explosion, and the unavailability of emergency medical care. RELEASOR AGREES TO FOREVER RELEASE AND HOLD HARMLESS HGF, DRESSAGE 4 KIDS, a non-profit organization, LENDON GRAY, HGF'S INDEPENDENT CONTRACTORS, ADMINISTRATORS, TRUSTEES, SUCCESSORS AND ASSIGNS, AND KIMBERLY VAN KAMPER BOYER, HER EMPLOYEES, INDEPENDENT CONTRACTORS, AND TRUSTEES (TOGETHER WITH "HGF" PARTIES), CAFÉ FREDO AND GREATEST HITS BBQ PC NOT LIABLE FOR ALL LIABILITY WHATSOEVER AND AGREES NOT TO SUE THE PARTIES ON ACCOUNT OF OR IN CONNECTION WITH ANY OR ALL CLAIMS, DEMANDS, RIGHTS OF ACTION OF WHATSOEVER KIND OR NATURE, DEATH AND/OR PROPERTY DAMAGE AS A RESULT OF AN ACCIDENT WHICH MAY OCCUR AS A RESULT OF PARTICIPATION IN ANY ACTIVITY DURING THE YOUTH FESTIVAL, OR ANY ACTIVITY IN CONNECTION WITH HGF OR PARTIES WHETHER OR NOT ATTRIBUTABLE TO NEGLIGENCE.
3. RELEASOR AGREES TO INDEMNIFY, DEFEND AND HOLD THE HGF PARTIES HARMLESS FOR ANY LOSSES, CLAIMS, DAMAGES, LIABILITIES AND OBLIGATIONS OF ANY KIND, INCLUDING REASONABLE ATTORNEY FEES INCURRED IN DEFENDING OR SETTLING SUCH LOSSES, CLAIMS DAMAGES, LIABILITIES AND OBLIGATIONS, ARISING OUT OF OR IN ANY WAY RELATED TO AN EQUINE ACTIVITY OR OTHER ACTIVITIES WHILE ON HGF PREMISES FOR THE YOUTH FESTIVAL.
4. Releasor agrees that the land and surrounding area on which the Hampton Green Farm facility is located including, but not limited to pastures, paddocks, roads and trails, may contain hidden defects unknown and unascertainable to HGF. Releasor agrees that, while every effort will be made by HGF to maintain a safe environment given the nature of the land and the farm there is that possibility that injury may occur. Releasor will agree to hold the HGF Parties harmless from, not liable for, and completely released from all liability and agrees not to sue them on account of or in connection with any injury, death or bodily arm sustained by Releasor or his/her/its horse due to a defect of HGF property.
5. Releasor agrees to waive the protection afforded by any statute or law in any jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing the release.
6. This agreement is made and entered into in the state of Michigan and shall be enforced and interpreted under the laws of this state. Should any clause be in conflict with state law, then that clause will be null and void.
7. HGF and Dressage 4 Kids, a non-profit organization, and Café Fredo agrees to provide a reasonably safe environment for this Festival and is in no way responsible for the inherent risks or for limiting such risks, attributable to equine activities.
